In 2025, Navy SeaPort Next Generation (NxG) selected **Bell Federal Systems Inc. (BFSI)** for a prime contract award. NxG is a multiple award indefinite-delivery/indefinite-quantity (IDIQ) contract that plays a critical role in bolstering naval operations. This cutting-edge vehicle encompasses services within two primary categories: Engineering Services and Program Management Services.

1. **Engineering services** include, but are not limited to, engineering, system engineering, and safety and process engineering support, as well as software engineering, development, programming, and network support.
2. **Program management services** include, but are not limited to, quality assurance support, database administration, Information System (IS) development, Information Assurance (IA), and Information Technology (IT) support.

## GSA OASIS+ CONTRACT AWARD

**RPS-JV3, LLC** is an SBA approved joint-venture partnership between Ross Professional Services LLC (RPS), **Bell Federal Systems Inc (BFSI)**, and MTNT Intelligence Solutions, LLC (MTNT). In 2025, RPS-JV3 was awarded an OASIS+ Small Business Government-Wide Acquisition Contract (GWAC) by the U.S. General Services Administration (GSA).

The One Acquisition Solution for Integrated Services Plus (OASIS+) is a suite of government-wide, multiple-award, indefinite delivery/indefinite quantity (IDIQ) contracts designed to meet federal agencies' needs for services-based solutions. Available to all federal agencies through a Delegation of Procurement Authority (DPA), OASIS+ includes a five-year base period with an optional five-year extension, offering a potential 10-year ordering period. Building on the success of the original OASIS and OASIS Small Business (OASIS SB) contracts, OASIS+ provides streamlined access to highly qualified contractors delivering complex, non-IT service solutions across the globe.



OASIS+ has an unlimited contract dollar ceiling, a five-year base and one five-year option contract period, and provides for long-term planning for complex program requirements.

## 8(a) STARS III

### GSA 8(A) STARS III CONTRACT AWARD

**RPS-JV, LLC** is an SBA approved 8(a) joint-venture partnership between Ross Professional Services LLC (RPS) and **Bell Federal Systems Inc (BFSI)**. In 2021, RPS-JV, LLC was awarded GSA's 8(a) STARS III Government Wide Acquisition Contract (GWAC). STARS III is a 'Best-In-Class' multiple-award IDIQ contract 8(a) STARS III is a multiple-award indefinite-delivery/indefinite-quantity (MA-ID/IQ) contract designed to provide federal agencies with innovative information technology (IT) services-based solutions from award-winning 8(a) small businesses.

In addition to the general IT services scope, 8(a) STARS III includes two focused scope sub-areas: Emerging Technologies (ET) and OCONUS Place of Performance. 8(a) STARS III prime contractors in the ET scope sub-area have experience providing evolving state-of-the-art emerging technologies such as technological convergence, robotic process automation, autonomic computing, and more. Prime contractors in the OCONUS scope sub-area have experience providing IT services in an Outside the Continental United States (OCONUS) location.

## State of Louisiana: IT Staffing Support

In 2024, Bell Federal Systems was awarded a 5-year multiple award contract to provide temporary Contract Staff Resources for a wide range of IT services to assist State agencies. IT Services include, but are not limited to, IT infrastructure, operations, technical services, support services, software application, reporting and analytics support. As of 2023, approximately \$128 million has been paid against the previous contract.



## Maryland Administrative Office of the Courts (AOC)

## **Commonwealth of Virginia, Department of Corrections**

In 2023, BFSI was awarded a prime contract to provide temporary medical staffing at 44 facilities across the state.

The roles include workers such as social workers, vocational rehabilitation counselors, chaplains, and other types of counselors. Licensed practical nurses, registered nurses, certified nurse practitioners, and physician assistants. Respiratory therapy assistants, hospital attendants, nursing assistants, dental assistants, emergency medical technicians, pharmacy technicians, psychiatric technicians, community health workers, dietetics technicians, medication assistants, physical/occupational therapist aide, training center direct care workers, and dental laboratory technicians.
